Dear Steina:

Thanks for your prompt reply. I m very glad that you will be able to come to Seattle in January. How does the weekend of the 15th-16th sound to you? If that's okay, we'll put that on our calendar.

As for determining what you want to do: We probably won't need to know definitely what you plan to do until the middle to end of December. We need lead time on special equipment. I should tell you that we have a very, extremely hard time getting 1/2" color decks and if you can, it would help us tremendously if you could bring your work on cassette (3/4) if it is in color. We can get 3650's easily, though, as well as a 3/4" player.

If you could send me by about the middle of December some information on yourself (vitae), and as much about the programs as you can, I can begin to do the publicity and flyer. It may be nice to use a photograph on the flyer, though it will be black and white. Either one of yourself or of your work will be all right. It may be nice to do a more formal program the first night with a more informal one on the second night. Or, whatever you decide. I doubt, unfortunately, that we will have a big enough audience to do the same program twice, but then you never know. Our usual programs last about 1½ hr - 2 hours each. The audience here varies from about 10 to 80 or 90 people.

I will contact Vancouver and Portland to see if something could be worked out at either of those cities. It would be nice for you to do something in one of those places while you are all the way out here. I will let you know as soon as I find anything out. I suppose I can imagine that the terms financially will be similar to ours, if that's all right.


I'm also enclosing a January calendar and a copy of the press release. I hope those look all right as well.
